THE POLITICAL THOUGHT OF XI JINPING: A CONVERSATION WITH DR. STEVE TSANG



Another brilliant China Power podcast. "Dr. Steve Tsang discusses his new book The Political Thought of Xi Jinping, coauthored with Dr. Olivia Cheung. Dr. Tsang explains that Xi Jinping thought is vastly different from the thought and practices of his predecessors, such as Mao Zedong and Deng Xiaoping. Core to Xi Jinping thought is the desire to achieve China's national rejuvenation and the embracement of the "Tian Xia" concept of Chinese hegemony. Dr. Tsang points out that Xi seeks to position China in a more prominent role on the world stage. Dr. Tsang highlights that through Xi's efforts to centralize the Communist Party under his control and to create an alternative to the US-led international order, Xi aims to reshape policy both within China and abroad. Finally, Dr. Tsang shares his thoughts on how best to deter Xi Jinping."




LIFTING THE LID ON CHINA'S SHADOW BANKS

THE DIGITAL SILK ROAD



Article 19 "examines China's digital infrastructure and governance influence in four countries: Cambodia, Malaysia, Nepal and Thailand. Because the Indo-Pacific will retain its strategic significance for China as it rolls out next-generation tech and seeks partners in normalising its authoritarian approach to digital governance, the report argues that assessing China's regional partnerships and what they mean for rising digital repression in the region is vital to understanding China's ambitions to rewire the world and rewrite the rules that govern the digital space." The document is 80 pages long so we advise grabbing a drink before diving in. We think this is a great piece to build knowledge of context around what China is doing.
